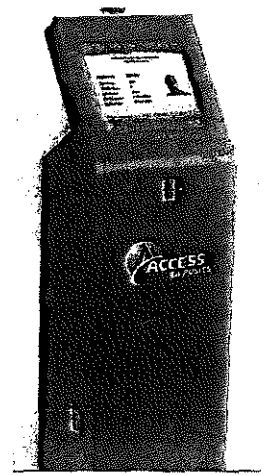


# DETAINEE FUNDS ACCEPTANCE POLICY

---



Detainee Funds are accepted for deposit into your commissary account by four different methods:

1. Detainees may have family or friends utilize the **Lobby Kiosk**
  - a. Family & Friends must have your Detainee ID Number or Name
  - b. The Kiosk accepts Cash, Credit, and Debit Cards
  - c. Cash is only accepted in increments of \$5 (i.e. \$5.00, \$10.00, \$20.00, \$50.00, etc.)
  - d. Funds are posted real time to the detainee's account
  
2. Detainees may have family or friends deposit funds via **Access Secured Deposits** by Access Corrections
  - a. Toll-Free, bilingual call center 1-866-345-1884 (24 hours/ 7 days a week)
  - b. Online at [www.inmatedeposits.com](http://www.inmatedeposits.com) (you will be redirected to [www.accesscorrections.com](http://www.accesscorrections.com)) (24 hours). Online deposits are less than over the phone.
    - i. For call center and online payments, family & friends must have your Name and Detainee ID Number
    - ii. State and Facility Name: Georgia / GEO Robert A. Deyton
    - iii. Payment by Credit, Debit and Prepaid cards are accepted
    - iv. Funds may take up to 24 hours to post due to verification of all cards for fraud.
  
3. Detainees may have family or friends send Money via **Western Union @ Quick Collect**
  - a. Call 1-800-238-5772 for Customer Service
  - b. Or go to your nearest Western Union location
  - c. Cash, Credit, and Debit Cards are accepted
  - d. The sender must have the following information
    - i. Pay to: ROBERT A. DEYTON
    - ii. Code City and State: RADEYTON / GA
    - iii. Account Number: DETAINEE #, LAST NAME
    - iv. Attention Field: DETAINEE FIRST and LAST NAME
  - e. Funds are posted according to the deposit times set by the vendor.
  
4. Detainees may have family or friends send a **Money Order or Cashier's Check** in the mail
  - a. **We do not accept cash!!**
  - b. Money Orders must arrive at least two business days prior to commissary to be available to the detainee
  - c. The Senders Name and Return Address must be on the envelope
  - d. The Senders Name, Return Address and the Detainee's ID Number must be on the money order  
**(POSTAL MONEY ORDERS CREDIT TO THE ACCOUNT IMMEDIATELY)**
  - e. The Money Order must be made payable to the Detainee
